

EXECUTIVE ORDER NO. 1536

WITHDRAWING LAND FROM THE OPERATION OF GOVERNOR'S
EXECUTIVE ORDER NO. 1446, DATED JUNE 14, 1951;
AND SETTING ASIDE LAND FOR PUBLIC PURPOSES.

WHEREAS, by Governor's Executive Order No. 1446, dated June 14, 1951, certain land situate at Kaneloa, Waikiki, Honolulu, City and County of Honolulu, Territory of Hawaii, was set aside as a site for a memorial park and natatorium, under the control and management of the Board of Public Parks and Recreation of the City and County of Honolulu; and

WHEREAS, a portion of said land, hereinbelow more particularly described, is required for the New Waikiki Aquarium to be under the control and management of the Board of Regents of the University of Hawaii; and

WHEREAS, the Board of Supervisors of the City and County of Honolulu has, by Resolution No. 513, dated August 21, 1952, approved the withdrawal of said land from the operation of said Executive Order No. 1446;

NOW, THEREFORE, I, OWEN E. LONG, Governor of the Territory of Hawaii, by virtue of the authority in me vested by Paragraph 2 of Section 73 of the Hawaiian Organic Act, and every other authority me hereunto enabling, do hereby order as follows:

1. That the following described portion of the memorial park and natatorium site, heretofore set aside by Governor's Executive Order No. 1446, dated June 14, 1951, be, and the same is, hereby withdrawn from the operation of said executive order:

Being all of Lots 114 to 118 inclusive and portions of Lots 113 and 119 of the Kapiolani Park Lots as described in Deed of Sanford B. Dole, President of the Republic of Hawaii to William G. Irwin, dated July 1, 1896, recorded in Book 164 on Pages 153-159, conveyed to the Territory of Hawaii by William G. Irwin Estate Company by Deed dated July 1, 1919 recorded in Book 525 on Pages 274-278 (Land Office Deed 1925).

Beginning at the northeast corner of this parcel of land, and on the southwest side of Kalakaua Avenue, the coordinates of said point of beginning referred to Government Survey Triangulation Station "LEAHI" being 2319.33 feet North and 3274.98 feet West, as shown on Government Survey Registered Map 3096 and running by azimuths measured clockwise from True South:-

1. 347° 22' 30" 310.25 feet along the southwest side of Kalakaua Avenue;
2. 77° 18' 288.53 feet along the Memorial Park and Natatorium, portion of Governor's Executive Order 1446;


Thence along seashore at highwater mark as described in the agreement between the Territory of Hawaii and various Waikiki property owners, dated October 19, 1928 recorded in Book 1047 on Pages 176-202 (Land Office Deed 3774), the direct azimuths and distances between points on said seashore being:

3. 166° 42' 36.00 feet;
4. 157° 35' 105.70 feet;
5. 159° 58' 37.00 feet;
6. 166° 27' 169.40 feet; thence
7. 257° 18' 214.43 feet along the Public Baths;
8. 347° 18' 36.00 feet along the Sewage Pump Lot, being portion of Governor's Executive Order 1446;
9. 257° 18' 99.95 feet along the Sewage Pump Lot, being portions of Governor's Executive Order 1446, to the point of beginning and containing an Area of 102,210 Square Feet.

2. That the above described land be, and the same is, hereby set aside as a site for the New Waikiki Aquarium to be under the control and management of the Board of Regents of the University of Hawaii.
